THE GOAL OF FINDING HOMES FOR THEM. DURING 2023, THE SHELTER SERVED  
2,625 ANIMALS AND HAD A SAVE RATE OF 94.2%. THE SPCA ALSO WANTS ALL  
ANIMALS TO STAY IN THEIR HOMES. TO ASSIST WITH THIS, THE ORGANIZATION  
HAS PROGRAMS THAT PROVIDE TEMPORARY HOUSING FOR ANIMALS, PET FOOD FOR  
PEOPLE WHO CAN'T AFFORD IT, AND MEDICAL CARE AT REDUCED COSTS. THE
